**2011 FEE SCHEDULE**

(SEAMO Approval: February 17, 2011)

Effective May 1, 2011, Queen's Family Health Team will implement a new policy for '**Third-party and Other Uninsured Services**' in our clinics. These fees will be for services not currently covered by OHIP (i.e. doctor's notes, driver's medical, etc). For a list of fees, please see chart below.

Accepted payments: **Interac**, **VISA** or **MasterCard**.

Please note that cash and personal cheques will no longer be accepted.

If you have questions or financial concerns regarding the policy, please speak directly with your Family Physician or Nurse Practitioner, **prior to the service being performed or completion of documentation**.

The Department of Family Medicine will review the fee schedule annually.
